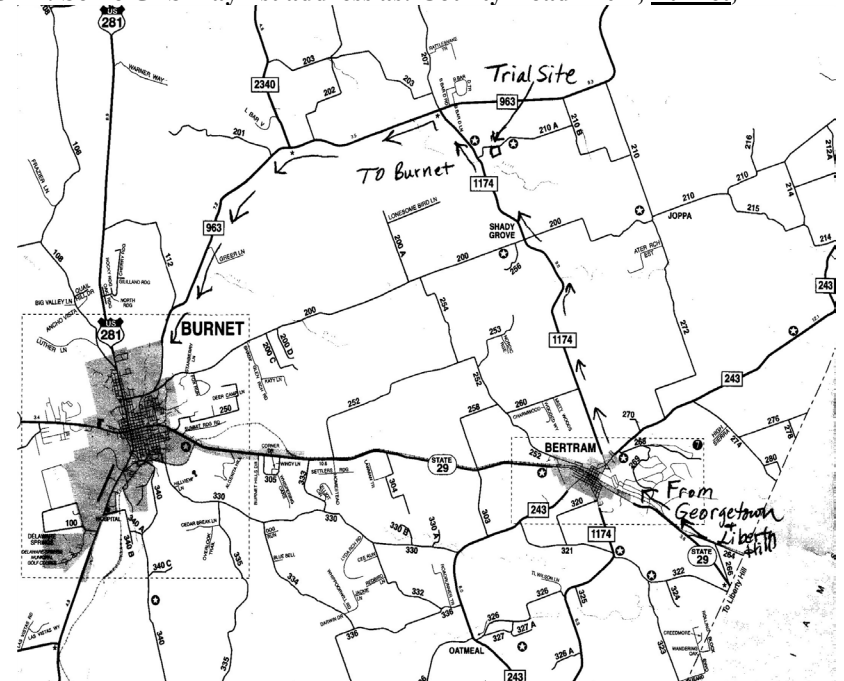

Directions to the Trial Site (From the east at IH 35 at Georgetown) **(Towns in order along Hwy. 29 heading west from Georgetown: Liberty Hill, Bertram, Burnet)**

Take Hwy 29 to Bertram. In the middle of town at the only signal light, turn North (right) onto RR 243/RR1174 also called Grange Street. Go 4/10 of a mile and turn left onto RR 1174 North. Go 7.6 miles and turn right onto County Road 210A. Go 6/10 mile. The road curves to the left and then to the right. We are the second property on the right at 601 County Road 210A, Destiny Farm. **Please keep gate closed.**

Notice to Exhibitors

- I. **Entry fees will not be refunded** in the event that a dog is absent, disqualified, excused, or barred from competition by action of the veterinarian, judge, or Trial Committee.
- II. **Entry fees will not be refunded** if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- III. **Lame dog policy**: If a dog is found to be physically unable to participate in the trial after the closing date, that dog may qualify for a refund in one of two ways. 1) If the trial is full and there is a wait list, and the owner/handler of the injured dog notifies the Trial Secretary at least 24 hours prior to the start of the Sunday trial, the first dog on the wait list that fits the stock availability and can be in attendance, will secure a place in the trial for no more than the number of runs the injured dog had entered, and the injured dog will receive a full refund. If no one on wait list fits the stock availability and/or can be in attendance, no refund will be given. 2) If the trial is not full, all entry fees will be refunded minus any recording fees due. In this case, a veterinarian's certificate MUST be submitted prior to 8:00am the day of the trial.
- IV. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In that case, no refund of any fees paid will be made.
- V. No refunds for duplicate entries. However, care will be taken to find duplicates before processing. Owners are responsible for errors in making out entry forms and no entry fee will be refunded in the event of such errors.
- VI. Checks that have been returned due to insufficient funds do not constitute a valid entry and will have a \$25.00 service charge attached.
- VII. Checks that have been post-dated do not constitute a valid entry.
- VIII. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- IX. Destiny Farm reserves the right to decline entries for cause and may remove any dog on account of aggression, disease, deformity, injury or illness which may affect the dogs' physical or mental performance. No one shall have any recourse or claim against Destiny Farm or any official thereof.

Destiny Farm does not agree to arbitrate claims as set forth on the official entry form for this event.

Eligibility

1. The Trial Program and Junior Herding Dog Program are open to all dogs 9 months of age or older. The Herding Capability Test Program is open to herding breeds and multipurpose breeds with herding background on the list at the end of the Test Program rules, six months of age and older.
2. Spayed bitches and neutered dogs may participate.
3. Bitches in heat may take part. In trial classes, bitches in heat need not wait until all other dogs have participated. In test classes, bitches in heat must wait until all other dogs have participated.
4. Dogs must be sound and in good health. Any dog which appears to be unfit will be removed at the judge's discretion; examples are: lameness, injury, illness, advanced pregnancy.
5. Owners of participating dogs need not be members of any club or organization.
6. A dog owned or co-owned by the judge or any member of the judge's immediate family or household may not be evaluated by that judge, nor may a judge evaluate a dog of which that judge has been the owner, co-owner or primary trainer/handler within the last six months.

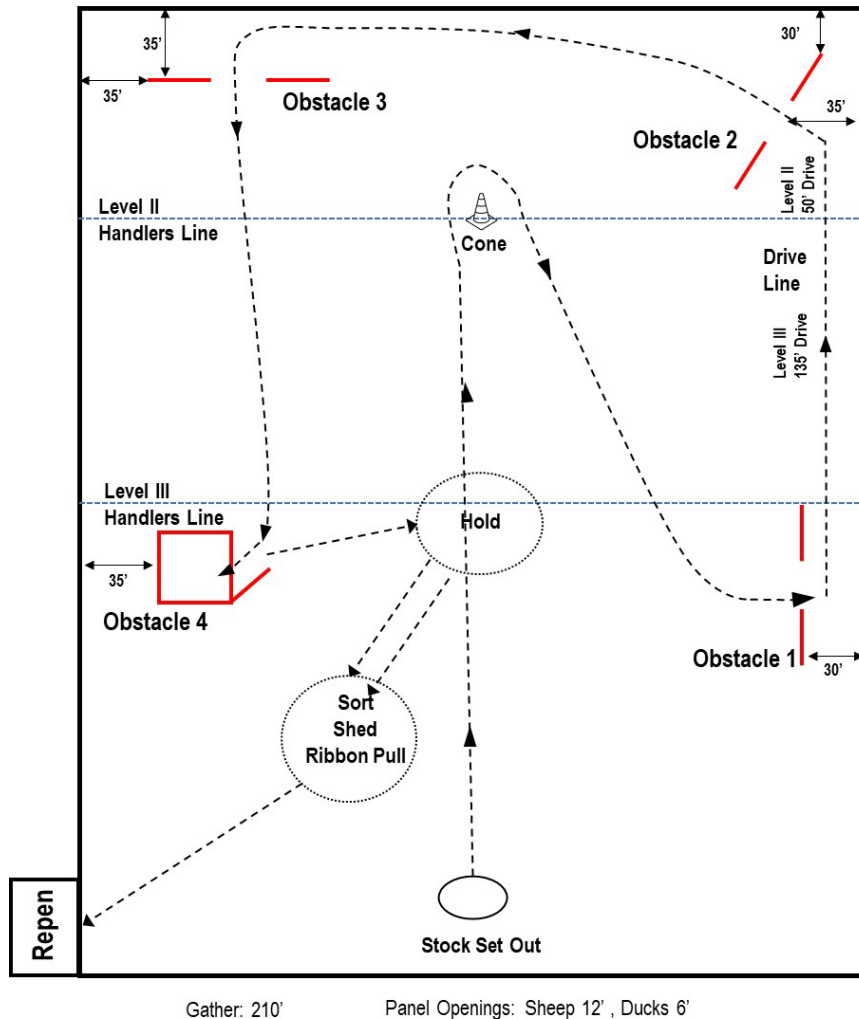
No dog may be entered in two classes on the same course with the same kind of stock under the same judge at any trial.

A dog must be entered in the name of the person(s) who actually owns it at the time entries are made for the Herding Test or Trial.

A Registration or Tracking Number must be included. Use your dog's registration number to enter. If your dog is not registered with any registry, then obtain a tracking number using the form on the AHBA website.

**NO FOOD will be available at the trial except for judges and worker lunches.

HTAD Course 5



HTAD COURSE #5 Description

The stock set-out is as indicated on the diagram for a gather. The handler's post is located a minimum of 100 ft. from the set-out. Obstacle I panel is located off the East fence, with the first panel built on the midpoint perpendicular from the mid-point and 30' off the east side of the arena. The panel obstacle has a 12 ft. opening. Obstacle 2 is located on a diagonal line

in the North East corner approximately 35' from the East fence at the midpoint of the entrance and 30' from the North fence at the beginning of the panel. The opening is 12 ft. Obstacle 3 is located at the North West corner parallel to the North fence 35' from the North Fence and 35' from the West fence. The opening is 12' wide. The freestanding pen is located 35 ft. from the West fence and 10 ft. from the midpoint and should be 8-10 ft. on each side for sheep, 10-16 ft. on each side for cattle. (A trailer or a free-standing chute may be substituted for the pen.) The hold area is located approximately halfway between the hold area and the repen gate. For poultry, all dimensions are $\frac{1}{2}$ that for hooved stock.

Gather or Take pen Gather: The stock are let out into the arena and allowed to settle, or may be set out in a specific location; the method used is to be consistent for all runs. In HTAD II, the handler may leave the dog at the handler's post and move to a point approximately halfway between the post and the stock, then send the dog to gather the stock. In HTAD I, the handler may leave the dog at a point approximately halfway between the post and the stock and move to approximately 15 ft. from the stock, then send the dog to gather the stock. At all three levels the stock are brought to and around the handler's post, passing just to the West of the handler's post and then turning South toward Obstacle 1. The gather ends when the stock have gone just past the handler's post. Take pen: HTAD III handlers must remain outside the pen while the dog brings out the stock. HTAD II handlers may enter the pen with the dog but should not move the stock themselves. HTAD I handlers may enter the pen and assist the dog in moving the stock. An exception is made for cattle, where the handler may go in and assist if necessary at any level. If the stock come out on their own volition without the handler or dog entering, there is no penalty. Once the gate to the take pen is opened, it may not be closed until the stock have exited. The stock are then taken to the handler's post, passing just to the West of the handler's post and then turning South toward Obstacle 1. Scoring for the take pen ends when the stock have gone just past the handler's post.

Obstacle 1: The stock should enter at the West opening of the obstacle and exit to the East. HTAD III handlers must remain South of the Advanced Handler's line until the stock have exited. HTAD II handlers may move along the wing of the obstacle but may not move past the wing until the stock have exited. HTAD I handlers may move anywhere relative to the obstacle but may not enter it. Scoring for Obstacle 1 ends when the animals have exited. Drive: After the stock exit Obstacle 1, they are turned back toward the North along the East fence going toward Obstacle 2. HTAD III handlers must remain behind the handler's line. HTAD II handlers may accompany the stock to the Level II handler's line to Obstacle 2, then must remain there

for the rest of the drive. HTAD I handlers may accompany the stock up to Obstacle 2. The drive ends when the stock reach a point 10 ft. in front of Obstacle 2.

Obstacle 2: The handlers remain at the designated locations while the stock are taken through the freestanding panels. While HTAD I handlers may go up to the panels, they should not precede the stock through the panels. Once the stock have gone through the panels, handlers are free to move along their handlers line except for Level I handlers who can move anywhere.

Obstacle 3: The stock are turned to the West to Obstacle 3 along the North fence and then turned to the South to enter Obstacle 3. Scoring for Obstacle 3 ends when the stock have passed to the South of the Obstacle and exited..

Obstacle 4 (Pen): The stock are taken South onto a line that will take them fairly directly to the area in front of the pen. The stock are penned in the freestanding pen. Scoring for the pen ends when the pen gate is closed.

Hold: The animals are taken to the hold area. The stock is settled and briefly held in place. There is no required position for handler or dog. The judge signals the end of the hold/settle. HTAD I and II handlers then take the stock to the repen. HTAD III handlers proceed with the sort.

Sort: The sort is done by HTAD III handlers only. The stock is moved to the designated area, which depends on the type of sort being done. The sort may be one of the following: (a) Gate sort. (b) Ribbon-removal/shed. The sort ends when the gate is closed on the sorted animals, or when the ribbon has been removed/ animals have been shed.

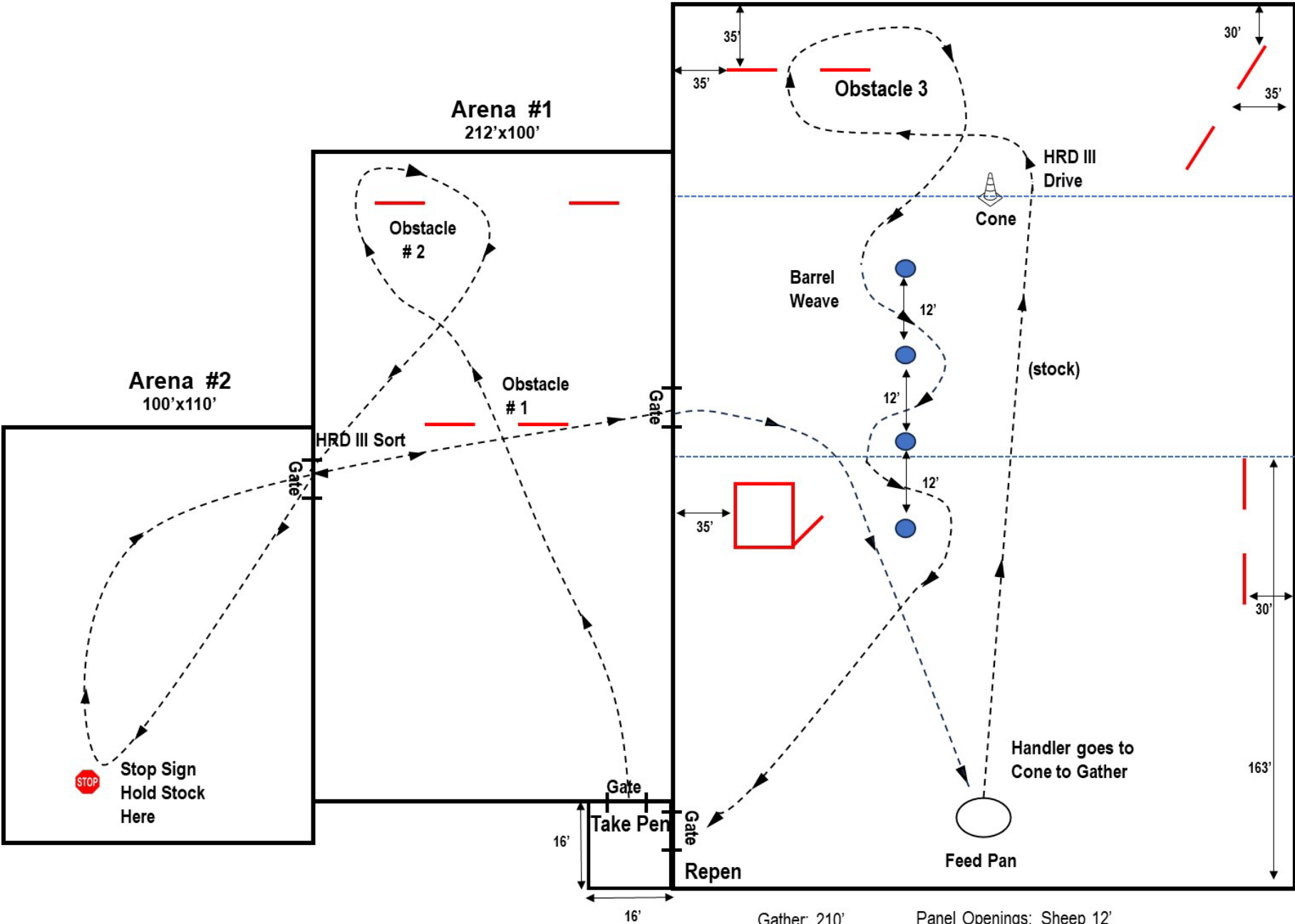
Repen: The stock are taken to the repen and held a short distance off the gate while it is opened, and then are repenned. When a gate sort has been used, the animals that had been left out in the arena are repenned. The run ends when the repen gate is closed after the last animal has exited the arena.

AHBA HRD COURSE 2024 DESCRIPTION

1. Take Pen: In the 16' x 16' take pen, stock are removed and headed into Arena #1 which is 212'x 100'. Open and close gate. HRD I handlers may enter the pen with their dog on leash if the handler chooses, but there must be a pause after the lead is removed before the dog is sent to collect the stock. Handler may move around to assist the dog as needed but may not touch the dog or stock without penalty. HRD II handlers may enter the pen but must remain just inside the gate while the dog moves the stock out of the pen. HRD III handlers may not enter the pen. HRD II and HRD III handlers must enter the pen off lead. Scoring for the Take Pen ends when the stock have exited and the gate is closed to Arena #1.

2. Obstacle 1: The stock are headed to and taken through the Center panel that have two 10' wide panels with a 12' opening.. All handlers can take the stock up to and through the panels but handlers may not enter the Obstacle. HRD III handlers remain on the line of the Center Panel and can move along that line side to side as needed once the stock have cleared the obstacle. HRD II handlers continue to take stock toward Obstacle 2 after stock have cleared the obstacle but no further than the HRD II handler line. HRD I handlers may move anywhere relative to the obstacle but may not enter it. Scoring ends when stock reach the HRD II handler's line.

3. Obstacle 2 & Wear/Drive: Stock are driven to Left Corner Panel with a 12' opening to the side and 12' to the back turning the stock to the left of the panel and then around to the right back of the panel. Then move stock toward Arena #2 Gate. HRD III handlers remain on the Center Line Handler's line until stock have cleared Obstacle 2 opening. HRD II handlers remain on their handler line until the stock have cleared the opening. HRD I handlers may not enter obstacle but can go up to the opening of the obstacle. Scoring ends when stock are turned toward the Arena #2 gate about 20' in front of gate.

4. Arena #2 Gate Sort: HRD III handlers will do a gate sort of 5 sheep into Arena #2 including one marked sheep with a ribbon. Close gate. Then reunite the remaining sheep into Arena #2 with the other sorted sheep.

5. Stop and Hold Stock: Open gate to Arena #2 and take stock through gate and close gate. Take stock to Stop Sign and settle stock and hold for a count of 12. Scoring then ends when stock are moved.

6. Arena #3 Gate to Feed Pan: All Handlers will move the stock back through Arena #2 gate and proceed to Arena #3 gate. Open and close all gates. Turn stock to the right and set stock on feed pan. Handlers proceed to Handler's cone at the opposite end of the Arena. Scoring ends when handlers reach the Handlers cone.

7. Gather: HRD III handler and dog start at the cone and handler remains at cone for the gather. HRD II handler sets dog at cone and handler may go halfway to the stock to send. HRD I handler's dog may be taken to a point halfway between the the cone and the stock and then the handler can go to with 15 feet of the stock. Send dog and stock are taken to right or east of cone then turning left to the back of the cone and heading toward Obstacle 3. Scoring ends when stock have cleared the back of the cone and heading left.

8. Obstacle 3 & Wear/Drive: Stock are driven to the left or west to the North fence through the freestanding panels. Stock are then turned to the right or west and then right or south toward the blue weave barrels. HRD III handlers remain behind the handler line and drive the stock through the panels. HRD II handlers may accompany the stock to the HRD II handler's line and then must remain along the line to drive the stock through the panels. HRD I handlers may go up to the panels but cannot go through the opening of the panels. Scoring ends when the stock have turned South towards the blue barrels.

9. Blue Weave Barrels: Barrels have a 12' width between the 4 barrels. All Handlers may negotiate in any manner weaving the sheep in and around the 4 barrels. Scoring ends upon completion of the weave.

10. Reopen: The stock are taken to the reopen and held a short distance off the gate while the gate is being opened and then repenned.
